Introduction:

Wycombe Wanderers Sports & Education Trust (WWSET) is committed to respecting all the data you share with us, keeping it safe and only using it in ways that are legitimate.

We will always be transparent about how we are processing your data and will only share it with other organisations if you have given us permission to do so and where we have legitimate cause to. This Privacy Notice sets out how we will collect information from people, how we will process it and what your rights are.

Where we collect information about you:

WWSET will collect information about you in a number of ways including when you:

- Access one of our services or activities;
- Book a holiday course;
- Attend an event;
- Apply for a job with WWSET;
- Make a donation;
- Enter a competition or prize draw;
- Give consent to receive our newsletter or other marketing information;
- Give consent for use of your image;
- Respond to enquiries;

How we use your personal data:

We collect personal data about people who use our services, support us or come into contact with us in another way. This is so that we can:

- Take your registration or payment details;
- Provide you with the services we offer;
- Process your employment application;
- Ensure you don't have to keep providing us with basic details when you interact with us again;
- Contact you for administrative purposes;
- Keep you up to date with our work (if you would like us to);
- Monitor our work;

- Create a profile of your interests and preferences. We do this to help us determine whether and in what ways you might be interested in helping us or getting involved in our activities.

What personal data we collect and how we use it:

We may collect personal data *(including special categories of data where appropriate and with your consent)* which includes the following:

- Name;
- Address;
- Email address;
- Telephone number;
- Date of birth;
- Gender;
- Equal opportunities monitoring information;
- Images;
- Current activities and interests;
- Ethnicity.

Depending on what service, event or activity you are accessing, we may also collect information about:

- Your health;
- Special educational needs or disabilities;
- Bank or payment details;
- Your Gift Aid status;
- Previous donations made;

How we keep your data safe and who has access to it:

WWSET will only collect and store the personal data that we need, and store it in line with relevant legislation.

All personal data that we collect will be stored securely in password protected systems. Only relevant staff will have access to this data. All staff and data processors that have access to your data will regularly undertake data protection training and abide by WWSET's GDPR Data Protection Policy and related procedures.

When we collect your personal information we will use strict procedures and security features to prevent unauthorised access. However, no data transmission over the Internet is 100% secure. As a result, while we try to protect your personal information, WWSET cannot guarantee the security of any information you transmit to us and you do so at your own risk.

Sharing your information:

Your rights:

- Object to the processing of your data where WWSET is relying on its legitimate interests as the legal ground for processing.
